### Questions Regarding Parking At Winfrey Point

The Dallas Arboretum is committed to working with the community and city officials to meet the needs of those who enjoy the lake and also want to visit the Dallas Arboretum, another landmark feature in the city's park system.

As the Botanic garden operates on City of Dallas Park Land and Winfrey Point also is owned and managed by the City, the garden asked for parking consideration there while construction was taking place on its new facilities, including those for parking. The Arboretum volunteers and employees have been allowed in the past three weeks to use the parking areas at Winfrey Point. To address the space considerations at this venue when a significant number of spaces were taken by Arboretum staff, the remaining garden staff and volunteers were sent to other offsite parking locations.

City officials have undertaken a study of the needs of this part of the lake and will make recommendations on how all of the needs of those who want to park at Winfrey Point can be met in an orderly way.

This week the construction of the first phase of additional Arboretum parking across Garland Road will be complete.
